Mechanical

Item No. 1 – Air Handling Units:

- A. All roof mounted air handling units shall each be provided with an overflow condensate switch mounted on the primary condensate drain pan of each unit. The overflow switch shall conform to UL 508 and shall shut off the equipment served in the event the primary drain is blocked. The controls contractor shall monitor the flow switch thru the energy management system and notify the end user, via the front-end graphics, of any trouble signaled by the sensor.

Item No. 2 - Clarification:

- A. On sheet M5.2, "Variable Frequency Drive Schedule", VFD-1, VFD-2, and VFD-3 shall each be sized to handle 25-horsepower pumps as noted on "Pump Schedule".

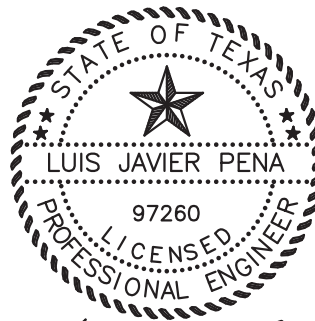
