Q & A Responses:

Question: We presume that the Instruction to Bidders, Agreement and P & P Bonds are not due at the time of bid.

Answer: The Instructions to Bidders section is only information to bidders, nothing is needed to be included in this area. The Agreement will be executed after the proposal has been evaluated, highest ranked has been selected and approved by the School Board. The P & P Bid Bond certificates need to be included with the proposal. Once the proposal has been approved, the awarded vendor will be required to then submit actual payment on the Bid Bond.

Question: We presume that the banking information being requested on the substitute W-9 form is not required at the time of bid, but to be provided by the awarded bidder?

Answer: We request that this information be submitted with the proposal but is not necessary. If awarded vendor did not submit with proposal, they will be asked to do so.

Question: Are the exterior hollow metal doors to be 14 or 16 gauge. Please see 081113-4, B,1.

Answer: Exterior hollow metal doors shall be 16 gauge.

Clarification: HVAC Commissioning is to be included in the scope of work by the General Contractor. Re: Specification section 23 08 00 for additional information.

Specification Section 10 21 13: Scranton Products Hiny Hiders is an approved manufacturer for the toilet partitions.
